President Zimmer declared a quorum present and called the meeting to order at 6:02 p.m. Gene Born gave the invocation and President Zimmer led the pledge.

## 1 - Public Comment

No public comments were received.

The General Manager reported that the District will have additional income of approximately \$45,000 from USDA NRCS which was not reflected in the draft budget. The General Manager also reported that Production Fees will be on the Board's September Agenda, but that \$60,000 in Production Fee income had been used in the 2016-2017 draft budget.

With the \$45,000 additional income from USDA NRCS; and if the District adopts the effective tax rate, the projected income for the District for 2016-2017 is \$2,895,871.46. As stated above, the projected expenses for 2016-2017 are \$2,859,575.07. This results in a projected positive budget for the District of \$36,296.39.

Danny Krienke moved to adopt the total expense budget of \$2,859,575.07 and the total income budget of \$2,895,871.46 as the District's 2016-2017 Budget. Gene Born seconded the motion and it passed by the majority vote of the Board with Zac Yoder opposing the motion.

# Action Agenda 3b - Consider action to adopt the proposed 2016 tax rate based on the 2016 effective tax.

The General Manager stated that on August 5, 2016, the Board proposed a tax rate that is equivalent to this year's effective tax rate of 0.034146/\$100 of property value. On August 7, 2016, *Amarillo Globe News* published 2016 Property Tax Rates for North Plains Groundwater Conservation District and District staff published the tax notice on the District's website on August 4, 2016.

The District is funded through ad valorem taxes, fees and grants. Ad valorem taxes are based on certified property values in the District. From year-to-year, the certified taxable property values may increase or decrease within each county. The table below shows the certified values by county for the last four years.

This year's *rollback* tax rate is the highest tax rate the taxing unit can set before taxpayers can start tax rollback procedures. Gene Born moved to adopt the effective tax rate for 2016 of 0.036877 per \$100 of valuation as the District's ad valorem tax rate. Danny Krienke seconded the motion.
