

Statements required in notice if the proposed tax rate exceeds the no-new-revenue tax rate but does not exceed the voter-approval tax rate, as prescribed by Tax Code §26.06(b-2).

NOTICE OF PUBLIC HEARING ON TAX INCREASE

This notice only applies to a taxing unit other than a special taxing unit or municipality with a population of less than 30,000, regardless of whether it is a special taxing unit.

The no-new-revenue tax rate is the tax rate for the 2023 tax year that will raise the same amount of property tax revenue for N PLAINS GRWATER CONS DIST from the same properties in both the 2022 tax year and the 2023 tax year.

The voter-approval tax rate is the highest tax rate that N PLAINS GRWATER CONS DIST may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that N PLAINS GRWATER CONS DIST is proposing to increase property taxes for the 2023 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON 09/12/2023 09:00 AM at NPGWCD CENTER, 6045 COUNTY RD E, DUMAS, TX.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, N PLAINS GRWATER CONS DIST is not required to hold an election at which voters may accept or reject the proposed tax rate.
