This notice concerns the 2023 property tax rates for North Plains Groundwater Conservation District

This notice provides information about two tax rates used in adopting the current tax year's tax rate. The no-new-revenue tax rate would impose the same amount of taxes as last year if you compare properties taxed in both years. In most cases, the voter-approval tax rate is the highest tax rate a taxing unit can adopt without holding an election. In each case, these rates are calculated by dividing the total amount of taxes by the current taxable value with adjustments as required by state law. The rates are given per \$100 of property value.

Taxing units preferring to list the rates can expand this section to include an explanation of how these tax rates were calculated.

Voter-Approval Tax Rate Adjustments

State Criminal Justice Mandate

The NPGCD County Auditor certifies that NPGCD County has spent \$ 0.00 *(minus any amount received from state revenue for such costs)* in the previous 12 months for the maintenance and operations cost of keeping inmates sentenced to the Texas Department of Criminal Justice. NPGCD County Sheriff has provided NPGCD information on these costs, minus the state revenues received for the reimbursement of such costs. Indigent Health Care Compensation Expenditures

Indigent Defense Compensation Expenditures


